

## **AUTHOR'S AGREEMENT**

1. I, \_\_\_\_\_, hereby transfer to Villanova University School of Law and the Villanova Environmental Law Journal (VELJ, Journal), the entire copyright on my article, \_\_\_\_\_ (Article), for its exclusive use as contemplated by this agreement. The Article is scheduled to be published in Volume \_\_, Issue \_\_ of the Journal, but such schedule may be changed as needed to accommodate publication deadlines. The Journal cannot guarantee an exact publication date. The Journal will make every effort to have the Article published as quickly as accuracy and outside circumstances will allow.
2. Provided that I am always expressly identified as the author, I grant the VELJ the exclusive right to publish and authorize others to publish the Article, including translations into any other language, in journals, magazines, newspapers, other periodicals, any electronic databases, and on the Internet.
3. For a period beginning on the date I accept the Journal's offer of publication and ending six months after the date of actual publication, I agree not to publish or distribute the Article in any form without permission of the Journal, with the exception of distribution of any reprints ordered at the time of publication and/or any appropriate educational uses as provided for in paragraph 7 of this Agreement.
4. After the end of such period, and notwithstanding the provisions of paragraph 2, I will have the right to use the Article, in its entirety or portions thereof, in my own future writings without obtaining permission from the Journal. I will also have the nonexclusive right to distribute any electronic version of the Article and place it on the Internet or any electronic database, except LEXIS, WESTLAW, and any other electronic databases with which VELJ has an existing agreement.
5. I warrant that I am the sole author of the Article, that the Article is original, and that the Article has not been previously published in whole or in part in any form, and that no agreement to publish the article elsewhere is outstanding. If the Article contains material that requires written permission for inclusion, I shall obtain such permission at my own expense from the copyright proprietor. I further warrant that publication in the Journal of the Article does not infringe upon any statutory copyright or upon any common law right and does not in any other manner infringe upon the rights of any person.
6. I agree to indemnify and hold harmless the Journal for any loss, expense (including reasonable attorney's fees) or damages arising from a breach of any of the warranties made in this Agreement.
7. I also grant Villanova University School of Law professors, instructors, lecturers, and teachers the right to photocopy the Article, in its entirety or portions thereof, for classroom

use, provided that: (a) the copies are distributed to students at, or below cost; (b) my name and that of VELJ are identified on each copy; and (c) proper notice of copyright ownership is affixed to each copy.

8. All editorial and Article copy is subject to the approval of the Editor in Chief of VELJ. I will be given the opportunity to read and comment on the substantively edited Article. I will be given the opportunity to correct the substantively edited Article and any other intermediate edits and/or page proofs. I have complete discretion to accept or reject any substantive changes to text and footnotes. The Journal retains the right to implement technical revisions. The Article is subject to any technical revisions that are necessary to meet the publication standards of VELJ. Technical revisions include grammar, punctuation, spelling, Blue Book citation form, and stylistic conventions as adopted by the VELJ. Substantive changes will be made only with the author's approval. In the event I should fail to make such changes that will ensure the publication quality of the VELJ, the Journal reserves the right to delay publication or make other arrangements in its discretion. The VELJ assumes no responsibility for the loss of, or damage to, the Article.

9. Any corrections I make during the editing process must be returned to VELJ in a timely fashion according to a mutually agreed upon date. In the event that I should fail to meet such deadlines within a reasonable period of time, the VELJ reserves the right to withhold publication or make other arrangements in its discretion.

10. The author will receive fifteen (15) covered reprints of the Article upon publication.
