



VIISTA Scholarship Application Requirements

Villanova University is pleased to offer a limited number of scholarships to financially support passionate champions of immigrant justice to enroll in VIISTA. Scholarships will be awarded at the start of each semester: Fall, Spring, Summer.

- ❖ Students can only apply once to the scholarship.
- ❖ Scholarships are renewable (each scholarship covers tuition costs for Modules 1, 2 and 3. You can take time off between Modules and are not required to take the Modules consecutively as long as you complete all 3 Modules within 3 years of the start of Module 1).
- ❖ Scholarship recipients must pass all courses with a grade of C or higher in order to maintain the scholarship award.
- ❖ Scholarships are awarded to first time, new VIISTA students. Students who have prior or current enrollment in VIISTA are not eligible.
- ❖ *Application Deadlines: 8/1 for Fall Semester, 12/1 for Spring Semester, and 4/1 for Summer Semester*

Please submit 3 Essays, using the following prompts.

- 1) Why do you want to participate in the VIISTA program? (250-500 words)
- 2) Please provide a summary of the work you would like to be able to do post-VIISTA, including the types of cases or clients you would like to serve (maximum 250 words)
- 3) Why are you seeking scholarship funds? (250-500 words)

Recommendation Forms (2 required) – please use the sample recommender form on page 2 of this document.

- 1) Please submit a recommendation form from your sponsoring organization. The form should be signed by a member of the organization's leadership team and indicate that the sponsoring organization is recognized by the DOJ or willing to seek recognition and willing to provide you with a paid or volunteer placement after you complete VIISTA. Sponsoring not-for-profit organizations must be:
 - a. Recognized by the Department of Justice (DOJ) to provide low or no cost legal services to migrants and refugees or willing to apply for DOJ recognition; and
 - b. Willing to provide employment or a volunteer position to the scholarship winner post-graduation. You can learn more about the DOJ recognition process here: www.justice.gov/eoir/recognition-and-accreditation-program.
- 2) Please attach a recommendation form completed by someone who can speak to the following: *your passion for immigrant justice, your previous community/volunteer work, OR your experience as a student.*
