New Business

1. Universal Lecture Capture – brief reports from department meetings, responses to recent questions, and discussion of drafting a letter (Katie)

It was reported that Law School faculty do have a choice to opt out of recordings. Faculty Congress will draft a letter that addresses some faculty concerns, including the need for longer notice, the preference for an opt-in system, and further transparency for both faculty and students. This letter will be subject to Faculty Congress approval and would be submitted to the Provost's office.

2. Support for robust discourse about abortion rights on campus (Katie & Joe)

Villanovans for Reproductive Justice, a nascent student group, is seeking official recognition and appears to be facing opposition. Faculty Congress discussed the need to support academic and intellectual diversity and freedom.

3. Update from Oct meeting with Provost and Vice Provost (Katie, Joe, Amanda, Bridget); call for topics for next meeting

CNT salary review is underway. Faculty Congress seeks suggestion for peer instistutions that might be used for comparsion. Any suggestions should be relayed to a FC representative.

Appendix A: Standing Committee Reports

1. Awards Committee (Andrew Scott [chair, external member], Sherry Burrell)

On Thursday, November 10, 2022 the Awards Committee met to discuss the nominations for this year's Facultas Award. From a number of worthy nominations, the committee makes the following recommendations.

First selection: Joyce Harden, Coordinator of Graduate Student Experience, Center for Graduate Research & Education

Nominators celebrated the breadth of Joyce's work across multiple areas at Villanova, most recently as Coordinator of Graduate Student Experience. She was praised for her ability to bring Villanovans together and described as a mentor, leader, and true unsung hero of Villanova – and, perhaps most significantly, "Wonder Woman" by those who have worked with her.

Second selection: Erin Spina, Assistant Registrar

Erin was praised for her work across the university, and in particular her ability to deal with difficult questions and challenging requests. In general, the work that this office does truly reaches across all departments in the university and though often unnoticed is certainly essential.

2. Research Policy Committee

The RPC has appointed committee members. They are currently working on Gift Card Policy with the Provost's Office.

3. Faculty Rights & Responsibilities Committee (FRRC; Amanda Knecht, chair)

RRC met on both October 27th and 28th to discuss how to incorporate ULC into the faculty handbook. We think that there can be some simple language added that makes it crystal clear that videos of professors teaching their regularly assigned courses (not for hire) are property of the professor. The current language says that videos belong to the creator, and we wish to make it clear that the professor is the creator of the recording, not the University. We were also asked by the Faculty Congress CNT members to reconsider letting CNT's vote for department chairs. The issue was discussed, and some more history of the voting rights debate was brought to light. The next step is for Amanda to talk to Alice Dailey to see where we can go with ULC and voting rights.

The Ombuds also reported to the FRRC chair and has some ideas for what the committee can do to address some of the concerns she has been brought in the past year. One initiative being taken is to develop a training for department chairs. Another pressing issue is formalizing a way for successful tenure and promotion cases to review the process. Currently, only unsuccessful candidates are afforded due process, and many successful faculty do not feel whole after promotion. One can find the annual report online:
